All questions must be fully answered. If you write on these blank sheets, however, be sure to give the number or numbers of the questions which you are answering.

Be sure to answer every question. If you do not know the answer to certain of the questions and cannot find out, write "I do not know," and then explain why you cannot secure the information.

Your attention is called to Section 5392 of the United States Revised Statutes (Title 18, Section 231 U. S. C.) which provides that whoever having taken an oath in any case authorized by law subscribes to any material matter which he does not believe to be true is guilty of perjury and shall be fined not more than \$2,000 and imprisoned not more than 5 years. A false answer to any of the questions may affect the decision on your release, parole, or internment.


